VOLUNTEER WAIVER & RELEASE OF LIABILITY

Acknowledgement of risks, assumption of risks, and Release agreement for all
NPMFS Volunteer-Musical Festival Activities

You have indicated an interest in volunteering for the North Pacific Music Festival Society (NPMFS). Prior to doing that you must accept, acknowledge, & agree to the items listed below). In addition, information collected on this form will be used to arrange liability insurance coverage with respect to your voluntary participation in the 2010 North Pacific Music Festival.

1. Volunteering may include being around electrical equipment, large groups of people, stage equipment, moving vehicles, et cetera. The leaders of this society are volunteers they are not paid. In all activities, all participants and volunteers share in responsibility for having appropriate skills, condition, and understanding for this activity.
2. I understand that the North Pacific Music Festival (aka NPMFS) staff, leaders, and board of directors or other personnel cannot assure volunteer and participants safety or eliminate risks. I am voluntarily participating with knowledge of the risks. Therefore, I assume and accept full responsibility for the inherent and other risks of these activities (both known and unknown), and for any injury, damage, death or other loss suffered by me, resulting from those risks.
3. I agree to release and not to sue NPMFS staff, or board of directors in regard to all claims, liabilities, suits, or expenses (hereafter collectively 'claim' or 'claims'), including claims caused or allied to be caused by the negligence of NPMFS (but not its gross negligence or intentional or reckless misconduct), for any injury, damage, death or other loss to me in any way connected with me volunteering or participation in these activities, or my use of NPMFS equipment or facilities. I understand and I agree here to waive all claims I may have against NPMFS, and agree neither I, nor anyone acting on my behalf, will make a claim or file a lawsuit against NPMFS.
